POWERSCHOOL PARENT PORTAL REGISTRATION FORM

Access to your child's grades and attendance through PowerSchool is provided to you as another form of communication with teachers and administrators. This process will help all of us in our efforts to support your child's education. Please read this form carefully, fill out the spaces provided, sign and date it. Return the registration form to your child's school. Present a photo ID, preferably a driver's license, so a copy can be made.

As a condition of using Power School, I understand and agree to the following:

1. Usernames and passwords are to be kept confidential.
2. Only one username and password will be issued per family/student.
3. All concerns about the system should be addressed to your child's school. (School & District staff cannot provide technical support for your home/work computer system)
4. Concerns about grades should be directed to your child's teacher by either setting up an appointment or sending an email directly to that teacher.
5. Even though you can check grades anytime during the day, teachers generally post their grades within five days of the assignment due date. Larger projects usually take longer to grade so please be mindful of possible delays of grade postings.
6. If you notice a mistake with any of your child's grades, please contact the teacher directly.
7. Attendance concerns should be addressed to the data clerk at your child's school.
8. If you forget your username and/or password, contact the school's main office and someone will assist you.
9. No usernames or passwords will be given out via email. Passwords will be reset and given out either in person through the school's office or over the phone with verification of your driver's license number, your child's date of birth and home/ mailing address confirmation.

Acceptable Use:

1. It is important to remember that the school district is providing this access as a privilege. I understand any misuse of the program may result in having my rights revoked without notice.
2. I understand the school district is not liable for any damages to my personal equipment incurred when connected to the PowerSchool system.
3. In consideration of using Anderson School District Five's network resources and having access to my child's grades and attendance, I hereby release Anderson School District Five and its officers, employees and agents from any claims and damages arising from my use or inability to use the system.
4. I understand that information in the PowerSchool System may not be correct. I should notify the appropriate individual regarding corrections. (See login page for additional information)
